

CHARTER ORDINANCE C-6
TO PROVIDE FOR THE APPOINTMENT AND TENURE OF THE
OFFICE OF VILLAGE CLERK

The Village Board of the Village of Oconomowoc Lake does ordain as follows:

Section 1. STATUTES NOT TO GOVERN. The Village of Oconomowoc Lake, pursuant to Sections 61.195, 61.197 and 66.01 of the Wisconsin Statutes, hereby elects not to be governed by those portions of Section 61.19 and 61.23 of the Wisconsin Statutes which relate to the selection and tenure of the Village Clerk and which are in conflict with this ordinance.

Section 2. APPOINTMENT. The office of Village Clerk shall hereafter be performed by the person nominated by the Village Board and elected by a majority vote of all of the members of the Village Board.

Section 3. TERM. The appointed Village Clerk shall hold office at the will of the Village Board, subject to removal at the pleasure of the Village Board, by a majority vote of all of the members of the Village Board.

Section 4. INCUMBENT. The incumbent Village Clerk shall continue in office until the appointment and qualification of a successor.

Section 5. DUTIES. The Village Clerk shall perform all of those duties required of the office of Clerk as may be provided by law or by any ordinance or other direction of the Village Board.

Section 6. OTHER. All ordinances, or parts of such ordinances, which are in conflict herewith are hereby repealed.

This is a charter ordinance and shall take effect 60 days after its passage and publication unless within such 60 day period a referendum petition as provided by Section 66.01 of the Wisconsin Statutes shall be filed, in which event this

ordinance shall not take effect until it shall have been submitted to a referendum vote of the electors and approved by a majority of the electors voting thereon.


