ORDINANCE NO. 109

AN ORDINANCE TO AMEND ORDINANCE 81,

AS AMENDED TO DATE

The Board of Trustees of the Village of Oconomowoc Lake hereby determines that West Beach Road and North Beach Road, within the corporate limits of the Village of Oconomowoc Lake, are roads which are frequented by children going to and from the shores of Oconomowoc Lake; are contiguous to areas where children are playing; are areas where individuals of all ages participate in recreational activities, including, without limitation, walking, jogging, running and bicycling, boat launching, ice fishing access and related activities.

Resolved that, in accordance with the authority granted by Section 349.11 and 346.57 Wis. Stats., Section 2 (2) of Ordinance 81 is hereby amended to read as follows:

- (2) Speed Limits Decreased: With the approval of the State Highway Commission, if so required, the speed limits set forth in Section 346.57 (4)(e), (f) and (g) Wis. Stats. are decreased as hereinafter set forth upon the following streets or portions thereof located within the Village of Oconomowoc Lake:
 - (a) Fifteen (15) miles per hour on North Beach Road and West Beach Road between Newport Road and Gifford Road from April 16 through October 15; and Twenty-five (25) miles per hour on the balance of N. Beach Road and W. Beach Road.
 - (b) Twenty-five (25) miles per hour on North Beach Road and West Beach Road from October 16 through April 15.
 - (c) Twenty-five (25) miles per hour on North Gifford Road between Highway 16 and North Beach Road.

- (d) Twenty-five (25) miles per hour on West Fairview Road between Highway 16 and the end of West Fairview Road.
- (e) Twenty-five (25) miles per hour on N. Hewitts Point Road between Highway 16 and the end of N. Hewitts Point Road.
- (f) Twenty-five (25) miles per hour on N. Lake Club Circle.
- (g) Twenty-five (25) miles per hour on W. Armour Road between the village limits and W. Beach Road.
- (h) Twenty-five (25) miles per hour on West Plank Road between Highway
 16 East to the Oconomowoc River.
- (i) Twenty-five (25) miles per hour on Valentine Road between West Beach Road and the Village limits.
- (j) Thirty-five (35) miles per hour on Sawyer Road, now designated as C.T.H. P, between S.T.H. 16 and Pabst Road.
- (k) Forty-five (45) miles per hour on Pabst Road between C.T.H. P and the West Village limits.
