

ORDINANCE NO. 175

AN ORDINANCE TO REPEAL, RECREATE AND CREATE
CERTAIN DEFINITIONS RELATED TO STREETS IN
SECTION 17.10 OF THE ZONING CODE
FOR THE VILLAGE OF OCONOMOWOC LAKE

The Village Board of the Village of Oconomowoc Lake, Waukesha County, State of Wisconsin
DO ORDAIN AS FOLLOWS:

SECTION 1: In Section 17.10 entitled DEFINITIONS the definition of "Street" is hereby
repealed and recreated to read as follows:

Street. Any highway, public street or private road as herein defined, intended for use as
public or private right-of-way for vehicular traffic.

SECTION 2: Section 17.10 entitled DEFINITIONS is hereby amended to include the following
additional definitions:

Public Street. Any street, highway, road or other way owned by or dedicated to the
Village of Oconomowoc Lake or governmental entity and used primarily for public
travel in motor vehicles.

Private Road. Any street, highway, road or other way that is privately owned, that is
used primarily for ingress and egress to and from lots by motor vehicles, and that is not a
private driveway as defined herein.


Private Driveway. Any way (1) serving not more than three lots, (2) used primarily for
ingress and egress to and from said lots by motor vehicles, and (3) for which ingress and
egress right is established by private easement and/or private ownership.

SECTION 3: SEVERABILITY. The several sections of this ordinance are declared to be
severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be
invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion
thereof directly specified in the decision, and shall not affect the validity of any other provisions,
sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force
and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are
hereby repealed as to those terms that conflict.

SECTION 4: EFFECTIVE DATE. This ordinance shall take effect immediately upon
passage and posting or publication as provided by law.

to-wit:


- (1) Opposite the entrance to the Oconomowoc Lake Club on the northern side of the road in front of the Club;
