

ORDINANCE NO. 183

AN ORDINANCE TO REPEAL AND RECREATE  
ORDINANCE NO. 4, AS PREVIOUSLY  
AMENDED BY ORDINANCE NO. 141,  
TO PRESCRIBE THE MEMBERSHIP OF  
THE BOARD OF REVIEW FOR THE  
VILLAGE OF OCONOMOWOC LAKE

The Village Board of the Village of Oconomowoc Lake, Waukesha County,

Wisconsin, DOES ORDAIN AS FOLLOWS:

SECTION 1: Section 2.04 of Ordinance No. 4, as previously amended by Ordinance No. 141, is repealed and recreated to read as follows:

2.04 BOARD OF REVIEW. The Board of Review of the Village shall be composed of

(a) the Village President, or in the absence of the Village President, a Village Trustee who shall be appointed by the Village President and subject to confirmation by the Village Board in April of each year.

(b) the Village Clerk/Treasurer, or in the absence of the Village Clerk/Treasurer, the Deputy Village Clerk/Treasurer shall serve.

(c) one Village resident, who may be a Village Trustee, who shall be appointed by the Village President and subject to confirmation by the Village Board in April of each year, or in the absence of said Village resident, another Village resident, again who may be a Village Trustee, shall serve who shall be appointed by the Village President and subject confirmation by the Village Board in April of each year.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful


or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.


This ordinance shall take effect immediately upon passage and posting or publication as provided by law.


