ORDINANCE NO. 192

AN ORDINANCE TO REPEAL
ORDINANCES NOS. 15, 34 AND 48
CONCERNING ELECTIONS,
AND TO INCORPORATE
WISCONSIN STATE STATUTES
REGARDING ELECTIONS
IN THE VILLAGE OF OCONOMOWOC LAKE

WHEREAS, on or about May 24, 1960, the Village of Oconomowoc Lake Village Board passed Ordinance No. 15 entitled "To Prescribe Procedures for the Filling of Elective Village Offices, To Regulate Elections Held in the Village, To Provide for Election Officials and Their Compensation, To Define the Qualification of Electors, and Related Matters"; and

WHEREAS, Ordinance No. 15 was amended on or about November 21, 1962, to change polling hours for elections held in the Village, and by Ordinance No. 48 on or about May 17, 1965, to change polling place for elections held in the Village; and

WHEREAS, in the ensuing four decades since Ordinance No. 15 was passed, many State laws have changed regarding the requirements for the conduct of elections in the Village of Oconomowoc Lake; and

WHEREAS, the Village of Oconomowoc Lake Village Board intends to repeal requirements of said ordinances that are in conflict with State law and have become obsolete, and to incorporate State laws on these subjects, including any amendments to the State laws that may be made in the future, to allow for uniform regulation of these issues throughout the State of Wisconsin and in the Village of Oconomowoc Lake; and

WHEREAS, as to those few matters that the Village of Oconomowoc Lake has lawfully chosen to regulate differently than prescribed by Wisconsin State laws, the Village of Oconomowoc Lake Village Board chooses to continue those local options as described herein.

NOW, THEREFORE, the Village Board of the Oconomowoc Lake, Waukesha County, Wisconsin, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: ORDINANCE NO. 15 REPEALED.

Village of Oconomowoc Lake Ordinance No. 15 entitled "To Prescribe Procedures for the Filling of Elective Village Offices, To Regulate Elections Held in the Village, To Provide for Election Officials and Their Compensation, To Define the Qualification of Electors, and Related Matters," dated on or about May 24, 1960, is hereby repealed.

SECTION 2: ORDINANCE NO. 34 REPEALED.

Village of Oconomowoc Lake Ordinance No. 34 entitled "To Change Polling Hours For Elections Held in Village," dated on or about November 21, 1962, is hereby repealed.

SECTION 3: ORDINANCE NO. 48 REPEALED.

Village of Oconomowoc Lake Ordinance No. 48 entitled "To Change Polling Place For Elections Held in the Village," dated on or about May 17, 1965, is hereby repealed.

SECTION 4: ADOPTION OF AUTHORITY.

The Village Board of the Village of Oconomowoc Lake has, by adoption of this ordinance, confirmed the statutory authority, powers and duties in Chapters 5, 6, 7, 8, 9, 10, 11, 12, 17, 61 and 66, Wisconsin Statutes, and establishes pursuant to the above-noted chapters and this ordinance, other statutory authority, powers and duties of the Village Board of the Village of Oconomowoc Lake related to certain elections and certain election procedures. All current provisions in Wisconsin State Statutes Chapters 5, 6, 7, 8, 9, 10, 11, 12, 17, 61 and 66, including any amendments, revisions, or renumbering that may be made to the same, shall apply within the Village of Oconomowoc Lake and are incorporated herein, to ensure uniform application of election laws throughout the State of Wisconsin and in the Village of Oconomowoc Lake.

SECTION 5: POLLING HOURS.

The polls for all elections held in the Village shall be open from 8:00 in the morning until 8:00 in the evening.

SECTION 6: POLLING PLACE.

The Village of Oconomowoc Lake shall constitute a single election district or precinct and, unless otherwise specified in the public notice of election, the polling place for such district shall be the Village Hall of the Village of Oconomowoc Lake.

SECTION 7: ELECTION OFFICIALS.

The following shall apply to election officials in the Village:

- a. Half-Day Election Officials. Appointment of election officials shall be made
 by the selection of two sets of officials to work at different times on Election
 Day.
- b. Reduction in Number. By Resolution No. 54 entitled "A Resolution Authorizing Reduction of Poll Workers," dated on or about July 12, 1994, the Village of Oconomowoc Lake has authorized a reduction in poll workers, and that reduction is continuing unless and until modified by resolution of the Village Board, provided that the number shall never be less than the minimum required by Wisconsin State law.
- c. Compensation. Election officials shall be paid a reasonable daily compensation, for work conducted on election day, or in the alterative, shall be paid by the hour at a proportionate rate for each hour actually worked on Election Day, as shall be determined from time to time by separate motion of

the Village of Oconomowoc Lake Village Board. The compensation shall not be less than federal minimum wage.

SECTION 8: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 9: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
