

ORDINANCE NO. 235

**AN ORDINANCE TO REPEAL ORDINANCE NUMBER 125,
REGARDING THE DESIGNATION OF PEDESTRIAN MALL
FOR WATERTOWN PLANK ROAD**

WHEREAS, the Village Board of the Village of Oconomowoc Lake designated Watertown Plank Road as a pedestrian mall by Ordinance Number 125; and

WHEREAS, the Village of Oconomowoc Lake Village Board now intends to discontinue Watertown Plank Road, by separate action; and

WHEREAS, the Village Board hereby intends to clarify that Watertown Plank Road will not continue to exist as a pedestrian mall, and will be discontinued fully upon the separate action to discontinue the road.

NOW, THEREFORE, the Village Board of the Village of Oconomowoc Lake, Waukesha County, Wisconsin, DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Village of Oconomowoc Lake Ordinance Number 125 entitled "An Ordinance to Designate a Portion of Watertown Plank Road in the Village of Oconomowoc Lake as a Pedestrian Mall Pursuant to Section 66.298, Wisconsin Statutes," dated on or about October 19, 1992, is hereby repealed.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance


are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.


AFFIDAVIT OF POSTING
