

ORDINANCE NO. 238AN ORDINANCE TO AMEND ORDINANCE NO. 178 ENTITLED
"AN ORDINANCE TO REGULATE OUTDOOR LUMINAIRES"

WHEREAS, the Village Board for the Village of Oconomowoc Lake has determined that certain modification need be made to ordinance no. 178 entitled "An Ordinance to Regulate Outdoor Luminaires; and

WHEREAS, the Village Board for the Village of Oconomowoc Lake has reviewed the original "WHEREAS" provisions of Ordinance No. 178 entitled "An Ordinance to Regulate Outdoor Luminaires" and reaffirms and incorporates the same into this ordinance;

NOW, THEREFORE, the Village Board for the Village of Oconomowoc Lake ,
Waukesha County, Wisconsin, DOES ORDAIN AS FOLLOWS:

SECTION 1: Section 1 entitled "Purpose, Applicability and Goals", subsection (c) of Ordinance No. 178 entitled "An Ordinance to Regulate Outdoor Luminaires" is hereby repealed and recreated to read as follows:

- (c) The provisions of this ordinance, except for Section 4(d), do not apply to commercial establishments as defined herein.

SECTION 2: Section 4 entitled "Requirements", subsection (b) entitled "Hours of Operation", subsection (iii) is hereby repealed and recreated to read as follows:

- (iii) Lighting commercial establishments if authorized as part of a conditional use permit as regulated in Section 5(e).

SECTION 3: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 4: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication

as provided by law.


