Ordinance No. 25

To Regulate Parking of Vehicles, to Decrease Speed Limits
and to Designate Through Streets and Class "B" Highways

The Village Board of Oconomowoc Lake do ordain as follows:

Ordinance No. 9 of the Village of Oconomowoc Lake, adopted March 12, 1960, is hereby amended as follows, the amendment to be effective after the passage and posting hereof and after the erection of suitable signs, except that the amendment to Section 7.02(2)(b) shall require also the approval of the state highway commission before becoming effective:

Section 7.04 is amended to read as follows:

Pursuant to section 349.13, and subject to the exceptions set forth in section 346.50, Wisconsin statutes, it is hereby declared unlawful to park or leave standing any truck, automobile, motorcycle, wagon or other vehicle upon any public highway or street in the Village.

Section 7.02(2)(a) is amended as follows:

Appendix 1 B shall list the following street upon which the speed limit is reduced to 15 miles per hour at all times when children are present:

Lake Club Circle

Section 7.02(2)(b) is amended as follows:

Appendix 1 C shall list the following streets upon which the speed limit is reduced to 25 miles per hour:

Beach Road
Gifford Road
Hewitt's Point Road
Fairview Road
Armour Road from Beach Road to west Village limits
Valentine Road from Beach Road to west Village limits

Section 7.03 is amended as follows:

Appendix 2 shall list the following street which is designated as a through street:

County Trunk Highway "P" (which includes Gifford Road and part of Beach Road) from the north Village limits to the south Village limits.

Section 7.05 is amended as follows:

Appendix 4 shall list the following streets which are designated as Class "B" highways:

Beach Road
Gifford Road
Valentine Road
Lake Club Circle
Fairview Road
Armour Road
Hewitt's Point Road



ORDINANCE


Ordinance No. 25
