

ORDINANCE NO. 283

AN ORDINANCE TO REPEAL AND RE-CREATE ORDINANCE NO. 142 ENTITLED  
AN ORDINANCE TO ESTABLISH AUTHORIZED SIGNATURES ON ALL VILLAGE  
CHECKS IN THE VILLAGE OF OCONOMOWOC LAKE

The Village Board of the Village of Oconomowoc Lake DO ORDAIN AS  
FOLLOWS:

SECTION 1: Pursuant to §61.24, 61.25, 61.26, and 66.042 of the Wisconsin Statutes, the Village Board of the Village of Oconomowoc Lake designates the following persons to be authorized to sign the Village of Oconomowoc Lake checks:

- A. The duly appointed Village Clerk/Treasurer or in his or her absence, the duly appointed Deputy Village Clerk/Deputy Village Treasurer;
- B. The duly elected Village President or in his or her absence, the duly appointed Chair of the Finance Committee or in his or her absence, the Village Trustee appointed by the Village Board as part of the annual appointment process.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.




SECTION 3: EFFECTIVE DATE.
