

Ordinance Number 46

An Ordinance to Amend Ordinance No. 9 Entitled
"To Regulate Traffic and Vehicles"

The Village Board of the Village of Oconomowoc Lake do ordain as follows:

Section 1. Section 7.02 (1) is hereby amended by adding to Appendix 1A the following:

W. Beach Road - 35 miles per hour
~~W. Valentine Road - 35 miles per hour~~

Section 2. Section 7.02 (2) (a) is hereby repealed.

Section 3. Section 7.02 (2) (b) is hereby amended by inserting in Appendix 1C the following:

N. Beach Road - 25 miles per hour
N. Gifford Road - 25 miles per hour
N. Hewitts Point Road - 25 miles per hour
W. Fairview Road - 25 miles per hour
W. Armour Road - 25 miles per hour
W. Plank Road from W. Wisconsin Avenue east to
the Oconomowoc River - 25 miles per hour
N. Lake Club Circle - 25 miles per hour

Section 4. Section 7.03 is hereby amended by inserting in Appendix 2 the following:

N. Gifford Road
N. Beach Road
W. Beach Road
W. Armour Road
W. Valentine Road
N. Hewitts Point Road

Section 5. Section 7.04 is hereby repealed and recreated to read as follows:

Pursuant to Section 349.13, and subject to the exception set forth in 346.50 of the Wisconsin Statutes for 1961, it is hereby declared unlawful to park or leave standing any truck, automobile, motor cycle, wagon or other vehicle upon any public highway or street in the Village of Oconomowoc Lake.

Section 6. Section 7.05 is hereby amended by inserting in Appendix 4 the following:

Section 8. Except as herein provided, said ordinance number 9 shall remain in full force and effect as originally passed.


Section 9. This ordinance shall take effect and shall be in full force after it's passage and posting.
