## ORDINANCE NO. 54

## Parede Permit Ordinance

The Board of Trustees of the Village of Oconomoroc Lake do ordain as follows:

## Section (1) PARADE REGULATIONS.

- (1) Definitions:
- (a) "Parade is any parade, march, ceremoney, show, exhibition, pageant, or procession of any kind, or any similar display, in or upon any street, park or other public place in the Village.
- (b) "Person" is a person firm, partnership, association, corporation, company or organization of any kind.
- (2) Permit Required. No person shall engage in, participate in, aid, form, or start any parade, unless a parade permit shall have been obtained from the Village Administrator.
  - (a) Exception. This ordinance shall not apply to:
  - 1. Funeral processions.
- 2. Students going to and from school classes or participating in educational activities, providing such conduct is under the immediate direction and supervision of the proper school authorities.
  - 3. A governmental agency acting within the scope of its functions.
- (3) Application: A person seeking issuance of a prade permit shall file an application with the Village Administrator on forms provided by such officer.
- (a) Filing Period. An application for a parade permit shall be filed with the Village Administrator not less than 60 days nor more than 90 days before the date on which it is proposed to conduct the parade.
- (b) Contents. The application for a parade permit shall set forth the following information:
- 1. The name, address and telephone number of the person seeking to conduct such parade:
- 2. If the parade is proposed to be conducted for, on behalf of, or by an organization, the name, address and telephone number of the headquarters of the organization, and of the authorized and responsible heads of such organization;
- 3. The name address and telephone number of the person who will be the parade chairman and who will be responsible for its conduct.

- 4. The date when the perade is to be conducted;
- 5. The route to be traveled, the starting point and the termination point;
- 6. The approximate number of persons who, and animals and vehicles which, will constitute such parade; the type of animals and description of the vehicles.
  - 7. The hours when such parade will start and terminate;
- 8. A statement as to whether the parade will occupy all or only a portion of the sidth of the streets proposed to be traversed;
  - 9. The location by streets of any assembly areas for such parades;
- 10. The time at which unites of the parade will begin to assemble at any such assembly area or areas;
  - 11. The interval of space to be maintained between units of such parade;
- 12. Any additional information which the Village Administrator shall find reasonably necessary to a fair determination as to whether a permit should issue.
- (c) Late Applications. The Village Administrator, where good cause is shown therefore, shall have the authority to consider any application hereunder which is filed less than 60 days before the date such parade is proposed to be conducted.
- (d) Fee. There shall be paid at the time of filing the application for a parade permit a fee of \$10.00.
- (4) Standards for Issuance. The Village Administrator shall issue a permit as provided for hereunder when, from a consideration of the application and from such other information as may otherwise be obtained, he finds that:
- (a) The conduct of the parade will not substantially interrupt the safe and orderly movement of other traffic contiguous to its route;
- (b) The conduct of the parade will not require the diversion of so great a number of police officers of the Village to properly police the line of movement and the areas contiguous thereto as to prevent normal police protection to the Village.
- (c) The conduct of such parade will not interfere with the movement of fire-fighting equipment enroute to a fire;
- (d) The conduct of the parade is not reasonably likely to cause injury to persons or property, to provoke disorderly conduct or create a disturbance;
- (e) The parade is scheduled to move from its point of origin to its point of termination expeditiously and without unreasonable delays enroute;
  - (5) Notice of Rejection. The Village Administrator shall act upon the

application for a parade permit within 10 days after the filing thereof. If the Village Administrator disapproves the application, he shall mail to the applicant within 10 days after the date upon which the application was filed, a note of his action, stating the reasons for his denial of the permit.

- (6) Appeal Proceedure. Any person aggrieved shall have the right to appeal the denial of a parade permit to the Board of Trustees of the Village. The appeal shall be taken within 5 days after notice. The Board of Trustees shall act upon the appeal within 30 days after its receipt.
- (7) Alternative Permit. The Village Administrator, in denying an application for a parade permit, shall be empowered to authorize the conduct of the parade on a date, at a time, or over a route different from that named by the applicant. An Applicant desiring to accept an alternate permit shall, within 5 days after notice of the action of the Village Administrator, file a written notice of acceptance with the Village Administrator. An alternate parade permit shall conform to the requirements of, and shall have the effect of a parade permit.
- (8) Contents of Permit. Each parade permit shall state the following information:
  - (a) Starting time:
  - (b) Minimum speed:
  - (c) Maximum speed;
- (d) Maximum interval of space to be maintained between the units of the parade;
- (e) The portion of the streets to be traversed that may be occupied by the parade;
  - (f) The maximum length of the parade in miles or fractions thereof:
- (g) Such infomation as the Village Administrator shall find necessary to the enforcement of this Ordinance.
- (9) Duties of Permitee. A permitee hereunder shall comply with all permit directions and conditions and will all applicable laws and ordinances.
- (a) Possession of Permit. The parade chairman or other porson heading or leading such activity shall carry the parade permit upon his person during the conduct of the parade.
- (10) Revocation of Permit. The Village Administrator shall have the authority to revoke a parade permit forthwith, issued hereunder upon violation of the standards for issuance as herein set forth.
- (11) We person participating in the parade may sell, distribute or give away in any manner any pamphlet, article, good, ware, merchandise or thing along the parde route while the parade is being conducted.

- (12) The person applying for and receiving a parade permit shall, at such time, submit a bond in the sum of \$3,000.00, which bond shall cover and protect the Village and its residents for any and all damage which shall have occurred as a regult or in consequence of the said parade.
- (13) Any violations of this ordinance, upon conviction, shall carry a fine in the sum of \$200.00 for each offense and each day shall be considered a separate offense.

This ordinance shall take offect after its passage and posting in accordance with the requirements of the law.
