

ORDINANCE NO. 88

Amendment to Ordinance 30, as amended to date.

The Board of Trustees of the Village of Oconomowoc Lake do ordain as follows:

Resolved, that Section 8.2 Membership of Ordinance 30 of the Village of Oconomowoc Lake be and herewith is repealed and amended to read as follows:

8.2 Membership.

The Board of Zoning Appeals shall consist of five (5) members appointed by the Village President and confirmed by the Village Board of Trustees.

TERMS shall be for staggered three-year periods.

CHAIRMAN shall be designated by the Village President.

TWO ALTERNATE MEMBERS may be appointed by the Village President for staggered terms of (3) years, in addition to the five (5) members above provided. Annually, the Village President shall designate one of the alternate members as 1st alternate and the other as 2nd alternate. The 1st alternate shall act, with full power, only when a member of the board refuses to vote because of interest or when a member is absent. The 2nd alternate shall so act only when the 1st alternate so refuses or is absent or when more than one member of the board so refuses or is absent.

ONE MEMBER shall be a Village Plan Commissioner.

SECRETARY shall be selected by the members.

ZONING INSPECTOR shall attend all meetings for the purpose of providing technical assistance when requested by the Board.

OFFICIAL OATHS shall be taken by all members in accordance with Section 19.01 of the Wisconsin Statutes within ten (10) days of receiving notice of their appointments.


VACANCIES shall be filled for the unexpired term in the same manner as appointments for a full term.


An Amendment to Ordinance 30, as amended to
