

**Short Term Disability Policy at it pertains to the Chief of Police/Administrator**

**RESOLUTION OF VILLAGE OF OCONOMOWOC LAKE**  
County of Waukesha

**WHEREAS** the Village of Oconomowoc Lake provides a short term disability policy for the full time police officers per the labor contract between the Police Officers and the Village; and

**WHEREAS** the Village and our labor contract agrees to provide a 60% salary coverage when utilizing sick leave; and

**WHEREAS** the Village has been notified that its current carrier will terminate the current short term disability policy effective May 1, 2007;

**WHEREAS** the Village has retained a new insurance carrier which limits the maximum cover of \$750.00 a week per employee; and


**WHEREAS** this limited coverage will only affect the current Chief of Police/Administrator whose salary exceeds the \$750.00 at 60% of the Police Chief/Administrator's weekly salary;

**IT IS, THEREFORE, RESOLVED THAT:**

The Village of Oconomowoc Lake Board of Trustees has agreed to compensate the current Chief of Police/Administrator and to maintain this 60% salary coverage for sick leave using insurance carrier funds and the balance using Village funds.




