

RESOLUTION NO. 71

RESOLUTION REQUESTING THE
WAUKESHA COUNTY BOARD OF SUPERVISORS
REJECT THE PROPOSED
LAND DIVISION AND DEVELOPMENT CONTROL ORDINANCE

WHEREAS, the Waukesha County Parks and Land Use Department has drafted a proposed Land Division and Development Control Ordinance (hereinafter "the ordinance"); and

WHEREAS, the ordinance, unavoidably, will increase County taxes for local residents; and

WHEREAS, the ordinance is poorly drafted and ambiguous; and

WHEREAS, the ordinance unlawfully regulates plats and CSMS; and

WHEREAS, the ordinance unlawfully and unfairly imposes park dedication fees; and

WHEREAS, the ordinance unfairly circumvents political process; and

WHEREAS, the ordinance unlawfully and unfairly burdens local municipalities with enforcement and taxation duties; and

WHEREAS, the ordinance contains unlawfully over-broad dedication requirements; and

WHEREAS, the ordinance includes duplicate charges and fees; and


WHEREAS, the ordinance will lead to increased litigation,

NOW, THEREFORE, BE IT RESOLVED that the Village Board of the Village of Oconomowoc Lake hereby finds that the draft Land Division and Development Control Ordinance is not in the best interests of the residents of the Village of Oconomowoc Lake, or in the best interests of the residents of Waukesha County; and, accordingly,

BE IT FURTHER RESOLVED that the Village Board of the Village of Oconomowoc Lake, by motion duly made, seconded and unanimously adopted, hereby urges the Waukesha County Board of Supervisors to reject the proposed Land Division and Development Control Ordinance.


