A RESOLUTION AMENDING RESOLUTION NO.98 AND  
SETTING THE FEE SCHEDULE  
FOR THE USE OF THE PUBLIC BOAT LAUNCH FACILITY  
OWNED AND OPERATED BY THE VILLAGE OF OCONOMOWOC LAKE

WHEREAS, the Village of Oconomowoc Lake owns and operates a public boat launch facility in the Village of Oconomowoc Lake; and

WHEREAS, Section 20.15 entitled Boat Launching, subsection 2.(1) states that the fee schedule for the use of the public boat launch facility owned and operated by the Village of Oconomowoc Lake shall be set by separate resolution of the Village Board; and

WHEREAS, the Director of the Water Safety Patrol unit has reported to the Village Board of the Village of Oconomowoc Lake that a clarification must be made to the current fee schedule as previously set by the Village Board of the Village of Oconomowoc Lake ; and

WHEREAS, the Village Board of the Village of Oconomowoc Lake is desirous of clarifying the fee schedule for the use of the public boat launching facility owned and operated by the Village of Oconomowoc Lake.

NOW THEREFORE, the Village Board of the Village of Oconomowoc Lake, Waukesha County, Wisconsin, does hereby resolve as follows:

Fee Schedule for Use of the Public Boat Launch Facility  
Owned and Operated by the Village of Oconomowoc Lake

State of Wisconsin Residents

Base Fee with no attendant present - \$6.00

Base Fee with attendant present - \$7.00

Payment of the base fee authorizes the parking of one motor vehicle or one motor vehicle and trailer combination, along with the launching of one boat/motor boat.

Additional Fees

Parking of additional motor vehicles or motor vehicle and trailer combinations - \$6.00 with no attendant present, \$7.00 with attendant present.

Launching of additional boat/motor boats - \$6.00 with attendant present, \$7.00 with no attendant present.

Seasonal passes will be charged at 10 (ten) times the base fee - \$60.00.

State of Wisconsin Non-Residents

Base Fee with no attendant present - \$6.00

Base Fee with attendant present - \$7.00

Payment of the base fee authorizes the parking of one motor vehicle or one motor vehicle and trailer combination, along with the launching of one boat/motor boat.


Additional Fees

Parking of additional motor vehicles or motor vehicle and trailer combinations - \$6.00 with no attendant present, \$7.00 with attendant present.


Launching of additional boat/motor vehicles or motor vehicle and trailer combinations - \$6.00 with no attendant present, \$7.00 with attendant present.

Seasonal passes will be charged at 10 (ten) times the base fee - \$60.00.
