Minutes of June 27, 2022

The Architectural Control Board (ACB) meeting was called to order at 6:00 pm by the Deputy Clerk. In attendance were Derek Pawlak, Jim Perkins, Sandy Eppers, Mike Bickler Sr., Russ Kohl, Michele Cannariato (Deputy Clerk), and Donald Wiemer (Zoning Administrator).

- 1. Motion (Pawlak/Kohl) to approve the minutes from the April 25, 2022 meeting subject to changes indicated by Mr. Pawlak. *Carried Unanimously*.
- 2. Discussion/action regarding the request of Greg and Janelle Peterson, 4654 Lake Club Circle, for changes to previously approved plans siding and window changes on the house and garage.

Don Wiemer presented the plans and changes to the residence. The list of changes is attached.

Motion (Bickler Sr./Kohl) to approve the plans as submitted. It was noted that the Zoning Administrator can approve the changes to the Fish Hut once the plans are submitted. <u>Carried Unanimously.</u>

3. Discussion/action regarding the request of OC Lake LLC, 35410 Pabst Court, for changes to previously approved plans.

Jorgan Hanson from Port City Studio explained the changes to the plans. The list of changes is attached. Material alternatives were discussed: Roofing will be a dark gray composite shingle, Da Vinci artificial slate, or Vermont slate. The limestone might be changed to a higher density material. The plans show that there will be limestone on the 1st level and stucco on the 2nd level, but that might change to stucco on both levels.

Motion (Bickler Sr./Perkins) to approve the plans as submitted. It was noted that all the alternatives were approved but plans with the final decisions should be submitted at the time of applying for a building permit. <u>Carried Unanimously.</u>
