DISCUSSION/ACTION REGARDING A REQUEST FOR ADDITIONAL SIGNAGE FROM ROUNDY'S SUPERMARKETS INC., D/B/A PICK 'N SAVE, LOCATED AT 36903 E. WISCONSIN AVENUE IN THE BUSINESS DISTRICT OF THE VILLAGE OF OCONOMOWOC LAKE

Mr. Bickler stated the request. Mr. Doyle, representing Doyle Sign for Roundy's Supermarkets, presented the request. The proposed signage will be composed of a 1'8" tall "PHARMACY" sign made up of individual letters mounted on a single raceway above a 1'3" tall "DRIVE-THRU" sign also made up of individual letters mounted on a single raceway. All letters will be individually back-lit and display black during the day and white when illuminated. The raceways will match the building exterior and the signage will not extend beyond the existing canopy over the drive thru window. Mr. Wiemer noted that Mr. Pat McAdams submitted the request for Roundy's Supermarkets as owner of the property.
