<u>Discussion/action regarding approval of minutes from the August 7, 2023 Plan Commission meeting.</u> Clerk Sayles noted that the motions with regard to the 2 Conditional Use requests and the motion regarding approval of a CSM were changed to "recommendation for Approval to the Village Board" to better reflect the action of the Plan Commission on those items.

Motion (Waltersdorf/Fitch) to approve the minutes from the August 7, 2023 Plan Commission meeting as amended by the Village Clerk. *Motion carried 5-0-1 (Mielke)*.

# Previously TABLED item: Discussion/action regarding approval of the proposed building plans for Grand Butterfly Productions, LLC; Paul Bielik, Agent; for the property at 36551 E Wisconsin Ave.; Tax Key OCLV0586999001.

Mr. Wiemer stated last month the Plan Commission asked the applicant for detailed drawings of the proposed building as well as a plan for existing buildings. The applicant provided color renderings of the new building and proposed improvements to existing buildings to match the new building. New trees were shown in front of the larger existing building. The new building does not include sewer/water and is intended strictly for storage. Plan Commission members requested detailed drawings of the building plan and landscape plan be submitted for the Architectural Control Board.

Motion (Heinrich/Mielke) to approve the proposed building plan as submitted subject to the review and approval of the Architectural Control Board. *Motion carried unanimously*.

## <u>Discussion/action regarding a request for a sign for Christina Sommer, D/B/A Sweat Shop Hot Yoga,</u> located at 36115 E Wisconsin Ave., Oconomowoc, WI 53066

Chairman Bickler stated this is an existing business in the Vic's Carpet building. Mr. Wiemer reviewed the plan submitted stating the sign replaces an existing sign. The new sign will be backlit and is slightly smaller than the existing sign.
