Motion to approve previous meeting minutes.

Motion (Bickler/Waltersdorf) to approve June 19, 2017 Public Hearing and Village Board meeting minutes as written, *Carried Unanimously*.

FINANCE COMMITTEE

Discussion/action regarding the monthly operating statement for June

Mr. Fischer noted there is nothing unusual. Building permit fees are high, and attorney fees are high due to Wisconsin Avenue and multiple ordinances. The operating statement was accepted by the Board.

ADMINISTRATOR

Discussion/action to change Ordinance 269 to allow ATV and UTV vehicles on designated routes in the Village of Oconomowoc Lake.

The Board opted not to pursue this ordinance change. No action required.

Discussion/action regarding acceptance of donations received from Village residents, as noted on Exhibit A, designated for use toward the fireworks display in July of 2018.

Mr. Bickler stated that the donation listed on the 2018 spreadsheet should be listed as a carryover from 2017 as it was intended to be used but was received too late to add to the fireworks program. Mr. Fischer agreed that was the proper accounting method for the Village.
