## **A REQUEST FOR A RESIDENTIAL CONDITIONAL USE PERMIT SUBMITTED BY DR. TIMOTHY AND MAUREEN HILL FOR THEIR PROPERTY LOCATED AT 34625 HARTWELL PLACE, OCONOMOWOC, WISCONSIN, FOR THE PURPOSE OF KEEPING CHICKENS**

The request made by Dr. Timothy and Maureen Hill for a residential Conditional Use Permit is to be allowed to keep between six (6) and ten (10) chickens, and no roosters, on their property. A chicken coop with fencing surrounding would be installed. Mr. Murry, of 4300 Mariner Circle, expressed his support of the Hill's request and complimented the Hills on the care of their property. He also stated that the properties in the area of the Hill's are approximately three (3) acres in size, so the chickens would not cause any problems to the surrounding properties.
