ORDINANCE NO. 180

**AN ORDINANCE TO CREATE
CERTAIN DEFINITIONS RELATED TO POLYSTRUCTURES
IN SECTION 17.10 OF THE ZONING CODE
FOR THE VILLAGE OF OCONOMOWOC LAKE**

The Village Board of the Village of Oconomowoc Lake, Waukesha County, State of Wisconsin, DO ORDAIN AS FOLLOWS:

SECTION 1: Chapter 17 of the Village of Oconomowoc Lake Zoning Code, Section 17.10 entitled Definitions, the definition of "Polystructure" is hereby created to read as follows:

POLYSTRUCTURE

A structure having a frame of steel or other materials which is covered with plastic, polyurethane, vinyl, canvas, or other similar flexible sheeting material.

SECTION 2: Chapter 17 of the Village of Oconomowoc Lake Zoning Code,

Section 17.10 entitled Definitions is hereby amended to include the following:

STRUCTURE, TEMPORARY

Any structure which is located on a lot for less than (12) days a year. All Polystructures, as defined in this section, shall be deemed Temporary Structures.

SECTION 3: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance

shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 4: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.


AFFIDAVIT OF POSTING

to-wit:


- (1) Opposite the entrance to the Oconomowoc Lake Club on the northern side of the road in front of the Club;
