RESOLUTION NO. 46

ESTABLISHING A FEE FOR CONDITIONAL USE PERMITS

WHEREAS, Section 17.51(5) of the Village of Oconomowoc Lake Zoning Ordinance requires that fees for conditional use permits be in the amount specified by the Village Board of Trustees; and

WHEREAS, the Village Board of the Village of Oconomowoc Lake has determined that the applicant for a conditional use permit shall pay a fee equal to the actual cost of any legal, planning, administrative or fiscal work which may be undertaken by the Village of Oconomowoc Lake in connection with the conditional use permit,

NOW, THEREFORE, BE IT RESOLVED that the Village Board of the Village of Oconomowoc Lake, Waukesha County, State of Wisconsin does hereby set the fee for conditional use permits pursuant to Section 17.51(5) of the Village of Oconomowoc Lake Zoning Code to be a fee as set, from time to time, by separate resolution of the Village Board plus the actual cost of any legal, planning, and engineering work which is undertaken by the municipality in connection with the conditional use permit. In addition to the above-noted fees, in the event any special meetings are called, either by the Village Board or the Plan Commission, for the benefit of the applicant of the conditional use permit, the applicant for the conditional use may be required to pay to the Village all expenses for such a special meeting, including any extra salaries paid to the municipal officials and employees. All such fees shall be paid by the applicant prior to issuance of the conditional use permit. At the time of filing an application for a conditional use permit, the applicant shall pay the fee as set, from time to time, by separate resolution of the Village Board which is not refundable.
